SUBJECT: SSHSP Cost Report WebEx Training Schedule

This Medicaid Alert provides notification of available dates for online training (WebEx) for those involved in the completion of the July 1, 2012 – June 30, 2013 SSHSP cost report, which is due January 31, 2014.

Purpose of SSHSP Cost Reporting Online Training (WebEx)

As required under Certified Public Expenditures, those school districts and counties that have billed or are intending to bill Medicaid for school supportive health services (dates of service July 1, 2012 – June 30, 2013) are required to complete and submit a cost report. Training on this cost reporting process, including the Medicaid Cost Reporting and Claiming System (MCRCS), is available and will be conducted online via WebEx. These online cost report training sessions will prepare school districts and counties for the submission of the annual SSHSP cost report for the July 1, 2012 to June 30, 2013 school year.

The WebEx cost report training sessions will include an overview of several key updates to MCRCS and the SSHSP cost reporting methodology.

At least one representative from each district or county (school business officials and/or those responsible for completing the cost report) is required to attend one of the online training sessions. Districts and counties will not be given access to the FY 2013 Cost Report in MCRCS

until they have participated in a WebEx training session. PCG will be using WebEx logins to monitor participation in the training sessions. In order to ensure that your district or county receives credit for participating in the WebEx session it is imperative that you login at the start of the WebEx session by entering your district or county name in the field titled ‘Your name’ and your email address in the field titled ‘Email address’. Random Moment Time Study (RMTS) coordinators/assistant coordinators are also invited to attend.

In-person training sessions may be available through the Regional Information Centers (RICs) as a supplement to the Web-Ex trainings if ten or more school districts/counties make a commitment to attend. Please note that an in-person, supplemental training through the RICs **does not** replace the requirement for participation in a Web-Ex session.
