SUBJECT: 10% County Chargeback – § 4408 of Education Law
(2018-19 school year and prior)

Section 4408 of the Education Law requires that a student's county of residence contribute 10% of the approved cost of July/August special education services provided to children with disabilities who are five through twenty-one years of age and eligible for such services pursuant to Articles 85, 87, 88 or 89 of the Education law.

Your County's 4408 Summer Chargeback Summary (EFH-415) and the year specific Verified County Chargeback for Summer Services reports (EFH-400) list **verified student approval records** as of March 31, 2020. Each chargeback listing reflects approved services rendered. These reports are available to your county via FTP files accessed using the SED File Transfer Manager (SED FTM). **Note - "CCCC" represents the first four letters of a county's name, except for New York City (NEWY) and Saint Lawrence (STLA). HHMM represents the 2-digit hour and minute the report was created.*

The chargeback will be accomplished by reducing your county's § 4410 Automated Verification Listing (AVL) reimbursement due your county when State funds become available. The posted report shows your 2018-19 chargeback amounts, along with any adjusted § 4408 chargebacks going back to the 2010-11 school year.
